ANYONE WHO REQUESTS OR SOLICITS A PROHIBITED STATEMENT OR RECOMMENDATION IS SUBJECT TO DISQUALIFICATION FROM THE POSTAL SERVICE AND ANYONE IN THE POSTAL SERVICE WHO ACCEPTS SUCH A STATEMENT MAY BE SUSPENDED OR REMOVED FROM OFFICE. THE UNITED STATES POSTAL SERVICE PROVIDES REASONABLE ACCOMMODATION FOR ANY PART OF THE APPLICATION, BIDDING, INTERVIEW, AND/OR SELECTION PROCESS, PLEASE CONTACT THE OFFICE IDENTIFIED ON THE VACANCY ANNOUNCEMENT. THE DECISION ON GRANTING REASONABLE ACCOMMODATION WILL BE ON A CASE-BY-CASE BASIS.
