

RETROACTIVE PAYMENTS UNDER THE 2024-2027 NATIONAL AGREEMENT

Below is an explanation on how one can review their paystub for Pay Period 08-2026 that includes the retroactive payment owed under the 2024-2027 National Agreement. Only APWU represented employees who are covered under this agreement will be receiving a retroactive payment. This includes members of the Clerk, Maintenance, Motor Vehicle Service, Operating Services, and Material Support Crafts. It ***does not include*** those APWU represented employees who are covered by IT/AS contract, the Postal Nurses contract, the HRSSC contract, or any private sector contract.

REVIEWING YOUR PAYSTUB

This is only an example. Everyone's paystubs will be different, but this can help you understand your pay adjustments for the retroactive pay. This paystub is for a full-time regular Level 4 Step O. Information has been redacted as necessary to protect the employee. Because of all the redactions you cannot add or subtract numbers because things like TSP withholding deductions were redacted.

- The retroactive period covered November 16, 2024, through August 22, 2025. A total of 20 pay periods (Pay Periods 25 and 26 of 2024 and Pay Periods 1-18 of 2025).
- There were two pay increases that should have occurred during this period for career employees. A 1.3% *General Wage Increase* and a \$395 per year *Cost of Living Adjustment (COLA)* that equates to \$0.19 an hour. PSEs will receive a 1.3% *General Wage Increase* and an additional 1% for a total of 2.3%.
- Employees will receive a 1.3% increase (2.3% for PSEs) for the entire period. The COLA will only apply to career employees and cover the time frame from March 8, 2025, through August 22, 2025 (12 pay periods—PP 7-2025 through PP 18-2025).
- Employees will not receive any retroactive pay if they did not receive pay under one of the APWU Pay schedules identified by the letter codes of P, C, or K. For example, if an employee is detailed to EAS as a 204-b, they will not receive retroactive pay for the time they were acting as a 204-b because they were paid under the EAS pay schedule. Nor would an employee receive retroactive pay from the Postal Service for any time they may have been paid by the Office of Workers Compensation Program (OWCP).
- You will need the full paystub from the LiteBlue web app. (could be up to 20 pages long).
- There will be multiple adjustments, and they may not be in order.
- Because the first pay increase under the contract did not occur until November 16, 2024, there will be no adjustments prior to Pay Period 25-2024.
- There will be one "adjustment" for PP 25-2024 through PP 08-2025. The example paystub has this highlighted in yellow.
- Pay Periods 09-2025 through 18-2025 will have an itemized adjustment appearing on the paystub.
- For every adjustment period—it is calculated as follows:
 - Paying you at the "new rate" of pay for the hours you worked/used paid leave for each week.

- Subtracting the amount that **you have already been paid** at the “old rate”. The difference is the “Total Hours Gross Pay” listed at the bottom of each adjustment section.
- Deductions will be taken from the retroactive pay for taxes (state, federal, municipal, Social Security, and Medicare). Deductions will be taken for the automatic TSP contribution and any additional contribution you elected. In addition, FEGLI insurance payments will be deducted if you have elected any of the optional coverage.
- You can see an example of this highlighted beginning on page 3 of the sample paystub.
- There will then be the “adjustments net”—that is the cash in your paycheck for each adjustment period after the appropriate deductions (taxes, TSP, etc.) are taken out. ***Please note that only the first itemized retroactive pay period is highlighted and explained. You can apply the same logic to remaining pay periods on your paystub because each pay period is calculated the same.***

REMEMBER THAT EACH PERSON WILL BE PAID A DIFFERENT AMOUNT. THESE PAYMENTS CANNOT BE COMPARED TO THE RETRO PAYMENTS OF ANY PREVIOUS CONTRACT BECAUSE EACH CONTRACT HAD A DIFFERENT PAY RATE AND RETROACTIVE PERIOD. NOR CAN THESE APWU RETRO PAYMENTS BE COMPARED TO ANY OTHER UNION’S CONTRACT AS THE TERMS AND RETRO-ACTIVE PERIOD OF THOSE CONTRACTS CAN BE SIGNIFICANTLY DIFFERENT.
